INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve investment returns that track the performance of the Philippine Stock Exchange Index (PSEi) by investing in a diversified portfolio of stocks. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO PERA Equity Index Fund is suitable for Participants with an aggressive risk profile and who seek potentially higher returns through stock market investments but are also aware of the possibility of capital losses that such investments may entail.
- ♦Participation in the Fund shall be open to Participants who are (a) individuals; (b) have legal capacity to contract; (c) who have a Philippine Tax Identification Number (TIN); and (d) whose funds are in a PERA.
- ♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years. The Fund is not suitable for short-term investing.

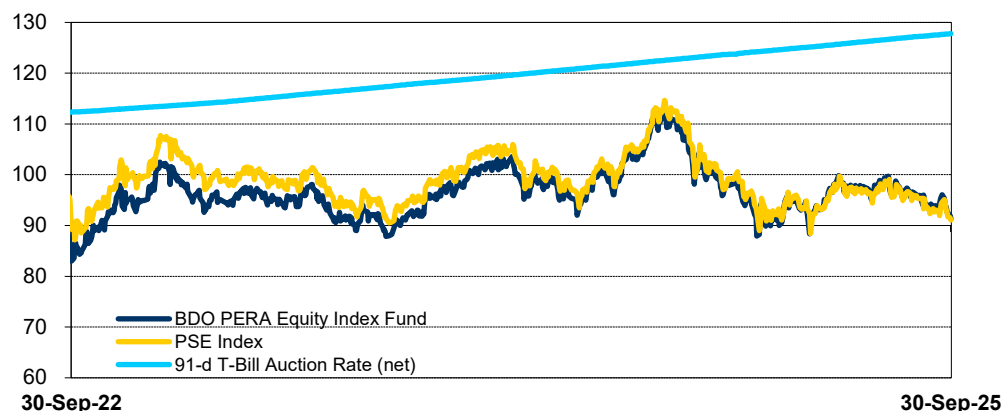

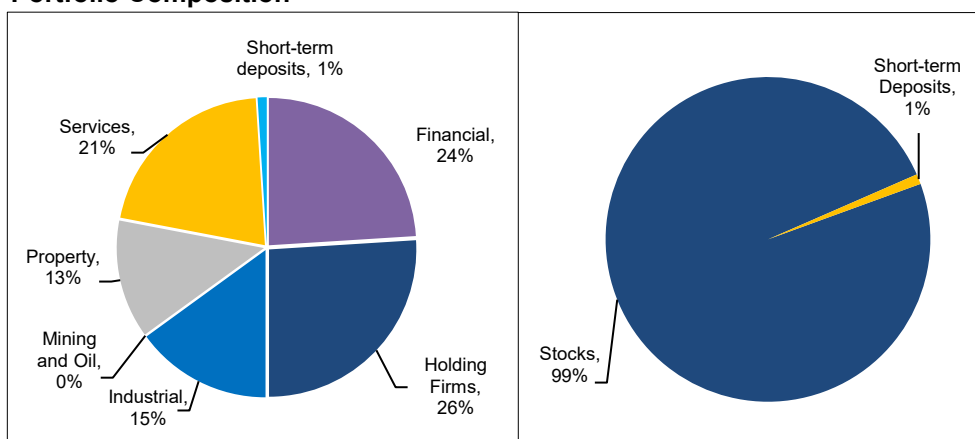
Fund's NAVPU vs Benchmark & Risk-Free Rate

OUTLOOK AND STRATEGY

It was another round of volatility for the equities market in September. The PSEi declined 3.28% m/m to close the end of 3rd quarter at 5,953.46. The market traded in the red as the corruption scandal slowly unfolded leading to a market sell off by foreign investors. The heightened political risk has dampened investor confidence as they assess the full impact of corruption in the flood control projects. This was reflective on the average daily turnover for the month which was lower by 8% from August level as traders remained cautious on the local market. Peso was also notably weak which depreciated by 1.8% m/m to Php58.205:\$1 amid political uncertainties and this added pressure to the dismal performance of the market. All sectors were on negative territory except for the Mining sector which gained 28.60% m/m as gold prices rallied to all time high. Best gainers for the month were PX (Philex), APX (Apex Mining) and OGP (OceanaGold) which all posted double digit positive returns in a month. However, the Property counter was sold down particularly ALI (Ayala Land) which fell 13% in a month as investors were pricing in a slowdown in high-end pre-sales. Moving forward, investors would likely stay on the sidelines as they wait for the 3rd quarter corporate earnings and development in the political front.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories allowed for Personal Equity and Retirement Account (PERA) UITFs as may be deemed suitable for the Fund.
