INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to provide investors with a total return which reflects the return of the Philippine Stock Exchange Composite Index (PSEi) by investing in a diversified portfolio of stocks that so far as practicable consists of the component companies of the PSEi. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

CLIENT SUITABILITY

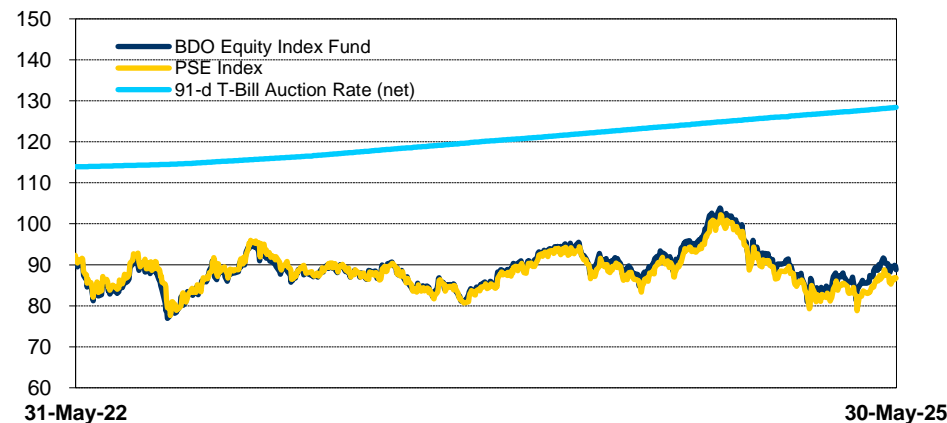

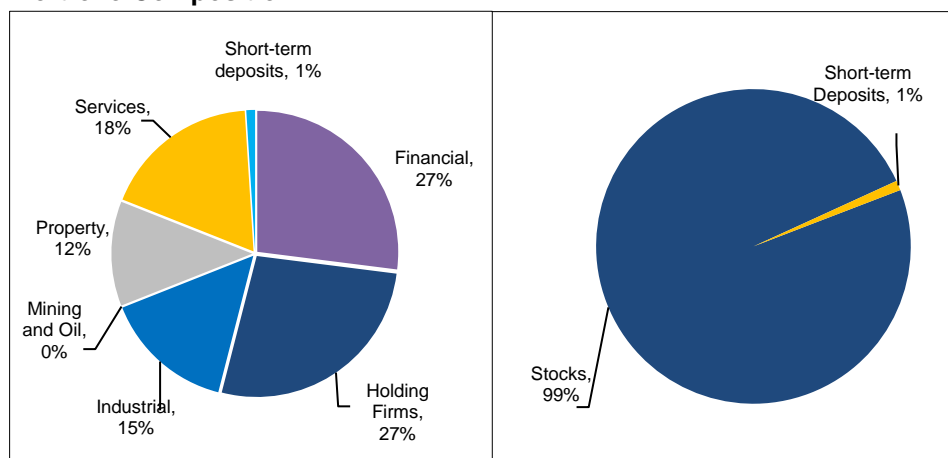

OUTLOOK AND STRATEGY

Local equities inched higher in the first half of May with the PSEi hitting almost 6,600 on signs of cooling tariff tensions, albeit a temporary trade deal between the U.S and China. The two countries agreed on a cut in reciprocal tariffs by 115% on most goods. The stock market took its cue following a relief rally across global stock markets on hopes of further easing trade tension. On the local front, the Peso’s appreciation to Php55 level alongside the continued downtrend in inflation for May at 1.3% lifted market sentiment. However, the market lost steam as investors shifted focus on local market moving news flow. For one, GDP in 1Q25 at 5.4% came out lower than consensus estimate of 5.7% on higher net imports and a softer investment growth. Also, first quarter corporate earnings were not that impressive and the mid-term election kept investors on the sidelines. Hence, the PSEi slightly declined by .21% m/m to end May at 6,341.53. Notable outperformers for the month were ICTSI (+20.5% m/m) on the back of the tariff rollback and AEV (+6.2% m/m) which was included in the MSCI Small Cap Index effective end May 2025.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee’s bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
