INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to provide investors with a total return which reflects the return of the Philippine Stock Exchange Composite Index (PSEi) by investing in a diversified portfolio of stocks that so far as practicable consists of the component companies of the PSEi. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

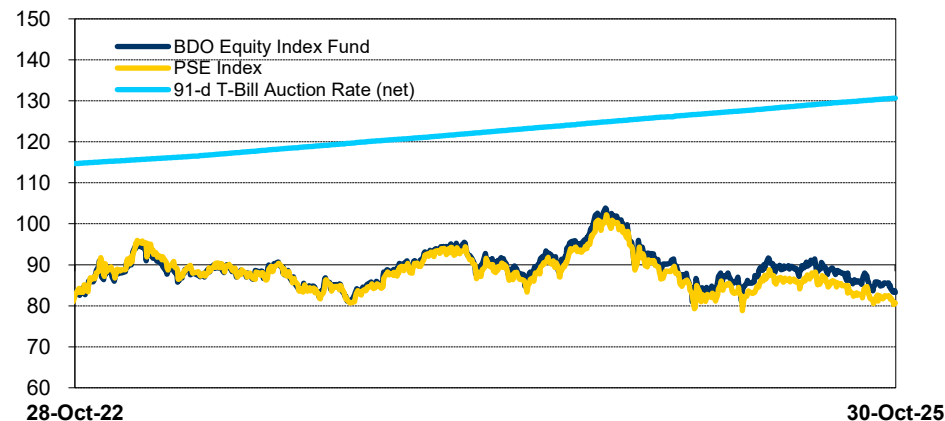

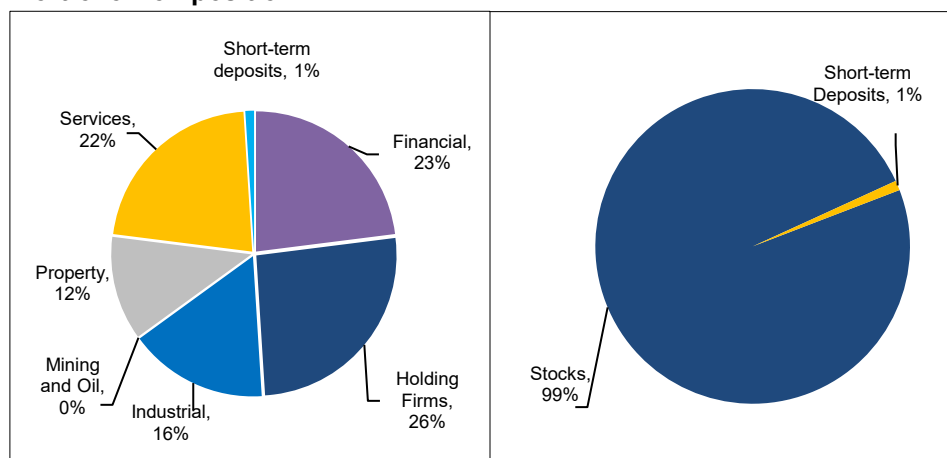

OUTLOOK AND STRATEGY

The PSEi closed the month of October at 5,929.68, its lowest close since April of this year. The equities market was down 0.40% m/m as investors' sentiment remained weak amid rising growth risks and the lingering political issue. Also, the BSP's surprise rate cut by 25 bps failed to perk up the market as the decision signals the need to boost the economy on slowing growth concern. Adding pressure to the negative sentiment was the continued slide of the peso hitting a record low of Php59:\$1 although the peso managed to recover from its lows, it still depreciated by 1.2% m/m to Php58.85:\$1. The Property sector remained the most laggard as foreign selling persisted weighed down by the corruption issue and its impact on high-end properties. Only a handful of stocks outperformed during the period such as ICTSI (+12.4% m/m) and MER (+10.4% m/m) on strong foreign inflows. Expect market to trade range bound as sentiment may likely remain cautious in the near term. The ongoing political issue is seen to remain an overhang for investors.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
