### **INVESTMENT OBJECTIVE AND STRATEGY**

The Fund aims for long-term capital appreciation by substantially investing in listed companies which the Trustee believes to exhibit good environmental, social and governance (ESG) practices. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi). "Environmental, social and governance" (ESG) refers to the three main areas of consideration as key factors in measuring the sustainability and ethical impact of an investment in a company or business. Within these areas are a broad set of concerns increasingly included in the non-financial factors that figure in the determination of a universe of investible outlets. ESG is the catch-all term for the criteria used in what has become known as socially responsible investing.

### CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

•The BDO ESG Equity Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who seek potentially higher returns through stock market investments but are also aware of the possibility of capital losses that such investments may entail.

•Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

### **KEY RISKS AND RISK MANAGEMENT**





### OUTLOOK AND STRATEGY

April was a tough month for both global and local equities market. The PSEi saw a sharp decline early April following the announcement of reciprocal tariffs on April 2 which Pres. Trump called the "liberation day". US stocks tumbled deeply to negative territory on fears of a US recession. Taking its cue from the movement in US markets, the local stock market was also sold down. The PSEi retreated back to the 5,800 level after the massive sell-off amid heightened concern on the escalating global trade tensions. Foreign investors turned heavy sellers of the market with a net outflow of \$54m for the month. Bargain hunters emerged though and lifted the market towards the end of the month to close at 6,354.99, up by 2.82% m/m. The local market got a boost from the strong rally in Wall Street after Pres. Trump announced a 90-day pause on certain tariffs to most countries except China. The buying spree was further supported by BSP's move to cut the policy rate by 25 bps to 5.50% on the backdrop of cooling inflation. April inflation eased further to 1.4% from March level of 1.8%. The peso's continued strength has also fueled some buying interest in the market, particularly on the foreign side. These positive macro factors remain supportive for a good market rebound.

### **INVESTMENT POLICY / PROSPECTIVE INVESTMENTS**

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in stock market prices affecting the Fund's investments. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market.
