INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation byinvesting in a diversified portfolio of peso denominated short to long-term fixed income securities, equity securities, and other allowable investments for UITFs. The allocation for equity securities shall not exceed 80% of the total portfolio of the Fund. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).



Fund's NAVPU vs Benchmark & Risk-Free Rate



OUTLOOK AND STRATEGY

April was a tough month for both global and local equities market. The PSEi saw a sharp decline early April following the announcement of reciprocal tariffs on April 2 which Pres. Trump called the "liberation day". US stocks tumbled deeply to negative territory on fears of a US recession. Taking its cue from the movement in US markets, the local stock market was also sold down. The PSEi retreated back to the 5,800 level after the massive sell-off amid heightened concern on the escalating global trade tensions. Foreign investors turned heavy sellers of the market with a net outflow of \$54m for the month. Bargain hunters emerged though and lifted the market towards the end of the month to close at 6,354.99, up by 2.82% m/m. The local market got a boost from the strong rally in Wall Street after Pres. Trump announced a 90-day pause on certain tariffs to most countries except China. The buying spree was further supported by BSP's move to cut the policy rate by 25 bps to 5.50% on the backdrop of cooling inflation. April inflation eased further to 1.4% from March level of 1.8%. The peso's continued strength has also fueled some buying interest in the market, particularly on the foreign side. These positive macro factors remain supportive for a good market rebound.

On local bond market space, yields were mixed, moving sideways to upward bias largely influenced by the BSP Monetary Board's decision to cut the policy rate by 25 bps as well as the bond offering of the new 10Y FXTN 10-73. The lower inflation, stable peso and BSP's further guidance of monetary easing will continue to influence bond market movement. April CPI print fell to 1.4% from 1.8% in March. Lower rice prices and rollback in pump prices drove inflation lower. This supports the view that the BSP will continue to cut rates this year.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in interest rates and stock market prices affecting the Fund's investments.

The Philippine Stock Exchange index (PSEi) measures the performance of the Philippine Stock Market. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market.
