INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a diversified portfolio of peso denominated short to long-term fixed income securities, equity securities, and other allowable investments for UITFs. The allocation for equity securities shall not exceed 80% of the total portfolio of the Fund. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Peso Multi-Asset Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.
- ♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

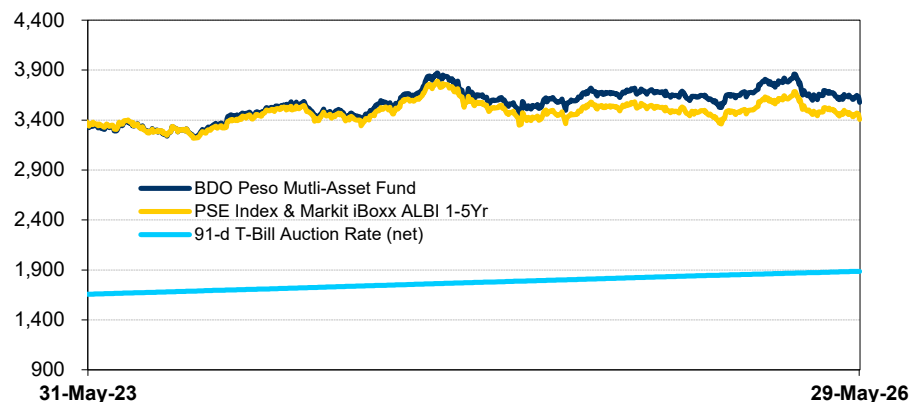

Fund's NAVPU vs Benchmark & Risk-Free Rate

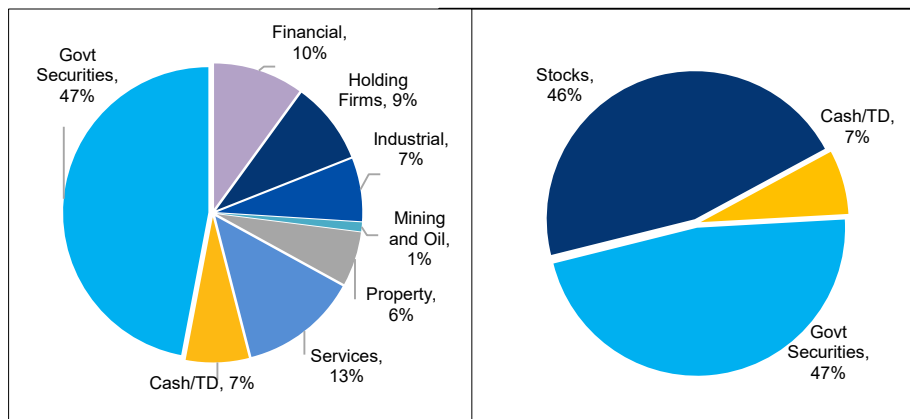

OUTLOOK AND STRATEGY

The PSEi traded within a narrow 5,800–6,000 range in May as investors remained cautious amid a challenging market backdrop. The index closed the month at 5,768.76, down 1.1% and marking its lowest level since November 2025. This represents the third consecutive monthly decline over the past five months. Persistent concerns over a weakening macro environment—including rising inflation, higher interest rates, and ongoing geopolitical uncertainty—continued to weigh on sentiment. Developments surrounding the US-Iran conflict, particularly alternating signs of de-escalation and renewed tensions, further pressured equities. The MSCI rebalancing at end-May further pressured equities, driving ~\$103 million in net foreign outflows, with significant selling in JFC (following its deletion to Small Cap), ICT, and MER. Meanwhile, currency weakness also dampened foreign participation, with the peso depreciating to a historic low of Php61.567 per US dollar.

The Philippine CPI for April surged higher to 7.2%, significantly higher than the market consensus and previous month's report at 5.5% and 4.1%, respectively, still mainly driven by the effects of the Middle East conflict on transport and fuel prices. Moreover, the 1Q26 GDP printed at 2.9%, well below market consensus of 3.3% and the weakest since the start of recovery from the pandemic. As the fund continues to take advantage of elevated interest rates, majority of the fund's investments are in government securities with a strong preference for liquid benchmark issuances.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

OTHER DISCLOSURES

The Fund aims to provide absolute returns in excess of the return of the composite benchmark, 50% Philippine Stock Exchange index (PSEi) and 50% Markit iBoxx Philippines 1-5 (Domestic) Index (IBXXPH15). The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in interest rates and stock market prices affecting the Fund's investments.

The Philippine Stock Exchange index (PSEi) measures the performance of the Philippine Stock Market. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market. The iBoxx Asian Local Bond Index family ("iBoxx ALBI") Philippines is designed to reflect the performance of local currency bonds with duration between 1-5 from the Philippine local currency bond markets whilst upholding minimum standards of investability and liquidity.
