INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a diversified portfolio of peso denominated short to long-term fixed income securities, equity securities, and other allowable investments for UITFs. The allocation for equity securities shall not exceed 80% of the total portfolio of the Fund. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Peso Multi-Asset Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.
- ♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

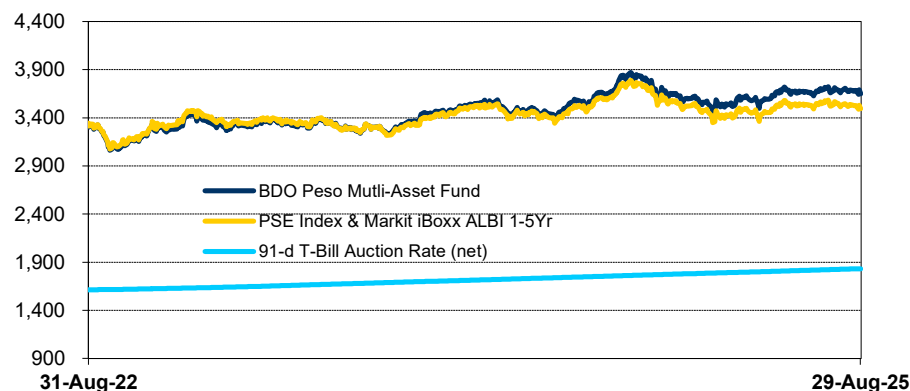

Fund's NAVPU vs Benchmark & Risk-Free Rate

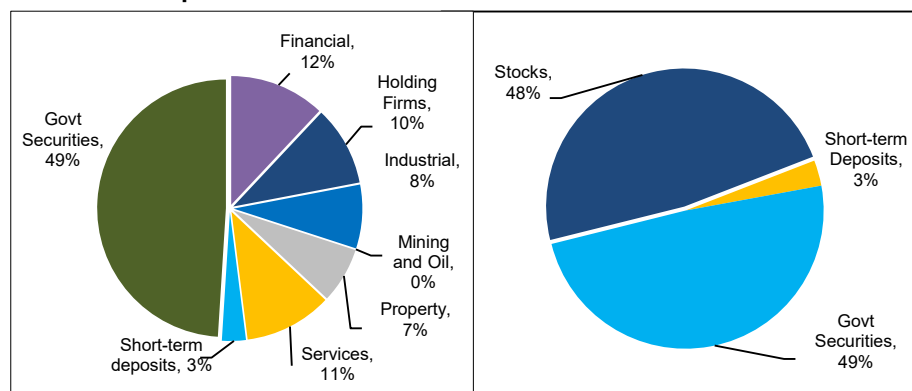

OUTLOOK AND STRATEGY

The stock market continued to languish in August with the PSEi slipping below the 6,200-mark to close at 6,155.57. The Index fell 1.55% m/m largely due to accelerated selling by foreign investors. The market has already registered five consecutive months of net foreign outflows as most investors remained risk-averse. Despite the widely anticipated BSP rate cut in August 28, market sentiment remained subdued. Also, the unimpressive second-quarter corporate earnings likely contributed to the lackluster performance of the equities market. Trading activity was generally muted, except during the two rebalancing events by the PSEi and MSCI Philippine Index. The online gaming Digiplus (PLUS) was added to the 30 Index members replacing integrated resorts, Bloomberry (BLOOM). Meanwhile, the MSCI Philippines saw the inclusion of Robinsons REIT (RCR) and Philippine National Bank (PNB) while D&L Industries (DNL) was removed. The month saw telcos posting big losses led by CNVRG (-21.7% m/m), followed by TEL (-12.0% m/m) and GLO (-9.8%). The sell-off was triggered by the Konektadong Pinoy Act which lapsed into law in August. The law aims to enhance competition however it is viewed to negatively impact the incumbent telco players.

Local bond yields generally moved lower driven by the BSP rate cut. The BSP cut its key interest rate by 25 basis points in August 28, marking its third consecutive cut for the year. BSP has already delivered 75 bps rate cut this year with the current policy rate at 5.00%. Meanwhile, inflation accelerated in August to 1.5% from July's print of 0.9%. The slight uptick was primarily due to weather-related disruptions that drove prices of vegetables and fish significantly higher.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in interest rates and stock market prices affecting the Fund's investments.

The Philippine Stock Exchange index (PSEi) measures the performance of the Philippine Stock Market. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market.
