INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation byinvesting in a diversified portfolio of peso denominated short to long-term fixed income securities, equity securities, and other allowable investments for UITFs. The allocation for equity securities shall not exceed 80% of the total portfolio of the Fund. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. 

Fund's NAVPU vs Benchmark & Risk-Free Rate



OUTLOOK AND STRATEGY

It was another round of volatility for the equities market in September. The PSEi declined 3.28% m/m to close the end of 3rd quarter at 5,953.46. The market traded in the red as the corruption scandal slowly unfolded leading to a market sell off by foreign investors. The heightened political risk has dampened investor confidence as they asses the full impact of corruption in the flood control projects. This was reflective on the average daily turnover for the month which was lower by 8% from August level as traders remained cautious on the local market. Peso was also notably weak which depreciated by 1.8% m/m to Php58.205:\$1 amid political uncertainties and this added pressure to the dismal performance of the market. All sectors were on negative territory except for the Mining sector which gained 28.60% m/m as gold prices rallied to all time high. Best gainers for the month were PX (Philex), APX (Apex Mining) and OGP (OceanaGold) which all posted double digit positive returns in a month. However, the Property counter was sold down particularly ALI (Ayala Land) which fell 13% in a month as investors were pricing in a slowdown in high-end pre-sales. Moving forward, investors would likely stay on the sidelines as they wait for the 3rd quarter corporate earnings and development in the political front.

On the local bond space, short-term yields moved lower while the medium to long term interest rates were slightly higher. Bond yield direction would continue to take its cue from US CPI and the FOMC meetings. On the local front, traders will continue to monitor the inflation print and the BSP's next move on policy rate cut. Meanwhile, September headline inflation posted at 1.7%, a modest rise from August level of 1.5%. This brings national average inflation of 1.7%. The higher inflation print was due to the slight uptick in food prices on account of a series of typhoons. Looking ahead, inflation would likely remain below BSP's 2% - 4% target.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.

The stated benchmark is a measure that is used to compare the performance of the Fund. The benchmark also represents the Fund's portfolio as well as the movements in interest rates and stock market prices affecting the Fund's investments.

The Philippine Stock Exchange index (PSEi) measures the performance of the Philippine Stock Market. The PSEi is made up of the top 30 largest and most active listed companies, chosen to represent the general movement of the stock market.
