In this Online Trading / Investment Facility Agreement (this "Agreement"), "I", "me" and "my" refer to the individual(s), corporation(s) or party/ies who is/are the account owner(s), has/have an interest in the account(s), and consent(s) to be bounded by the terms of this Agreement. On the other hand, "you", "your", "BSC" refer to BDO Securities Corporation, its employees, officers and directors.

"Securities" refer to securities, bonds, funds, managed funds and other investible products securities.

"BDO Uni bank" shall refer to BDO Unibank, Inc., a universal bank organized and existing under the laws of the Philippines.

"BDO Securities Online" or "Online Trading / Investment Facility" is the online trading facility of BSC or its successor.

"Website" refers to http://www.bdo.com.ph/securities or other sites authorized by BDO Securities Corporation

References to the Securities and Exchange Commission (SEC), the Philippine Stock Exchange (PSE or the "Exchange"), the Bangko Sentral ng Pilipinas (BSP), the Anti-Money Laundering Council (AMLC), Bureau of Internal Revenue (BIR), The Philippine Dealing & Exchange Corp. (PDEX), the Philippine Depository and Trust Corporation (PDTC), the Capital Markets Integrity Corporation ("CMIC") and the Securities Clearing Corporation of the Philippines (SCCP) shall be deemed to refer also to their successors in interests and assigns.

BSC is a registered SEC licensed broker of securities. In consideration of your acting as my broker of securities in the buying and selling of my account/s, I hereby consent to all the transactions being governed by the rules and regulations of the PSE, SCCP, SEC, BSP, BIR, PDEX, PDTC, CMIC, AMLC, and all other relevant government agencies and regulatory bodies, the Foreign Accounts Tax Compliance Act, customs and usages of the foregoing, and other applicable governmental authority, rules and regulations, and the following terms and conditions:

- 1. Client Identification. I am a depositor in good standing with BDO Unibank, Inc. I am aware of your explicit policy that business transactions will not be conducted with me if I fail to provide satisfactory evidence of my identity upon opening of my Beneficiary Account with you. The signature(s) appearing on the BDO Unibank, Inc. bank account opening form is/are true and official signature(s) of the account and may be used for verification of the said signature(s) at all times and for all purposes.
- 2. Warranty of Information. I represent and warrant that all information provided by me pursuant to this Agreement are true, complete and accurate. In case of any change in said information, I shall inform you immediately. I also hereby authorize you to conduct such credit or background checks to verify any information provided by me, and to ascertain my financial situation and investment objectives.
- 3. Buy and Sell Orders. Any electronically executed order made by me for the purchase or sale of Securities shall be binding on me (i) upon making the order online through the Website, and (ii) upon receipt of a confirmation notice sent through the Website. You may rely or act upon such executed orders, and you shall not be liable for any loss or damage suffered by me, provided that there is no willful fraud or gross negligence on your part. You require that the net value of the Securities I execute to be purchased will be within the total of my cash deposit and approved credit limit on my first trading transaction before my execution of the order, or in the case of Securities to be sold, I understand that you require advance delivery of Securities duly endorsed and cleared by the transfer office before my execution of the sell order. In the event a sell order is intentionally or inadvertently accepted and executed without the required stock certificates deposited in my account, I agree to immediately deliver to you the Securities sold in good deliverable and negotiable form. I am responsible for any losses or expenses incurred by you as a result of my failure to make such delivery. In order to complete my short sale (when allowed), you may need to borrow the Securities I sold and did not own. I will be subject to a buy-back of the security for my account and at my expense. If the Securities are bought in, I will be responsible for any resulting losses and all associated costs incurred by you. The proceeds of all sales will be retained in my Beneficiary Account unless I request otherwise. In the event the remittance of proceeds shall be made to an account outside of the Philippines, I hereby authorize BSC to convert such proceeds in the foreign currency of my choice. BSC may source the funds within or outside the Philippine banking system, as may be allowed by law. All remittance and conversion charges shall be for my account. You shall have the right, whenever in your sole or exclusive discretion, and whenever necessary for your protection, in the event that: (i) a petition for bankruptcy, or for appointment of a receiver is filed by or against me, or (ii) an attachment is levied against my account(s) with BSC: (x) to close any or all outstanding orders, as well as, to sell any or all Securities in my account, (y) to transfer money or Securities from any one of my account(s) to another, and (z) to buy any or all Securities which may be short in such account(s), all without the need of notice or demand for margin, additional security or collateral, or notice of sale or purchase, or any other notice or advertisement, all of which are hereby waived. Any such sales or purchases may be made at your discretion and you may be purchasers or sellers for your own account. Notwithstanding the foregoing, I shall, at all times, be liable for the payment of any amount owing on my account(s) with you upon demand and that I shall be liable for any deficiency remaining in any such account(s) in the event of the liquidation thereof in whole or in part by me or by you. For the purpose of buying, selling, or performing other acts pursuant to the above paragraph, I hereby irrevocably appoint you, your successors or assigns, as my attorney in fact with power to buy, sell or act, for any of my account(s) (whether carried individually or jointly with others), to agree upon the price of said Securities, execute bills of sale, receipts, assignments of all my rights, title and interest to the purchaser(s) thereof. You are also authorized to deliver or accept delivery of the corresponding stock certificates and/or any portions of the Securities held under any of my account(s) (whether carried individually or jointly with others) and herein pledged, to be transferred to your name or your nominee. I understand that you maintain a "Customer First" policy. When you execute buy or sell orders for your own account, you will prioritize my orders.
- 4. Trading Periods. I am aware of the trading periods specified by the relevant exchanges and over-the-counter market participants. Orders given by me during market recess shall be queued and posted once the trading session resumes on a first-come-first-served basis. Orders given by me outside of the relevant trading periods (off-hours) shall be queued and posted on the next pre-open period on a first-come-first-served basis.
- 5. Beneficiary Account and BDO Securities Settlement Account. I understand and agree that I shall have two accounts involved in opening an account with BSC applicable to either Philippine peso, US dollar or such other foreign currency accounts:
  - a. Beneficiary Account. My active Savings or Checking Account (Philippine Peso, US Dollar and/or other foreign currency) with BDO Unibank that is enrolled in the BDO Online banking facility that I nominate upon my online account opening with you for the purpose of account information data-pull, and the destination account where proceeds of my withdrawal request of cleared funds shall be credited. The username and password of my Beneficiary Account will be used to open my trading / investment account with BSC to enable me to use the Online Trading / Investment Facility, and I will be solely responsible for any and all orders placed electronically through my trading / investment account.
  - b. BDO Securities Settlement Account. I authorize BDO Unibank, through BSC, to open on my behalf this Settlement Account (Philippine Peso, US Dollar, and/or other foreign currency), using my personal information in my Beneficiary Account, as part of my online account opening with you. I understand that this will serve as my dedicated Settlement Account solely for my BSC transactions. I also acknowledge that this Settlement Account has the following features:
    - (1) It is a regular savings account (Philippine Peso, US Dollar and/or other foreign currency) under my name, without an ATM card or passbook;
    - (2) It is an interest-bearing savings account subject to BDO Unibank's prevailing rate on its regular savings accounts;

- (3) It has no Average Daily Balance requirement;
- (4) Deposits to this account are allowed through all available channels and credited in real time;
- (5) Withdrawals of cleared funds from the account could only be executed online through the BDO Securities Online Trading / Investment Facility for real time credit to my nominated Beneficiary Account;
- (6) I understand and agree that BSC and its authorized third-party providers and suppliers shall be the only party authorized to initiate debits on this account for settlements of my BSC related transactions.

- (11) In the event that I trade in Dollar Denominated Securities (DDS) and/or Real Estate Investment Trust (REIT), foreign currency denominated securities and/or other securities and investible products, I hereby instruct and authorize BSC to open sub-accounts under my name with Philippine Depository & Trust Corporation (PDTC) (NOCD Name on Central Depository), PDEx, Mutual Fund companies and nominated global custodians for foreign currency securities in compliance with the requirements of the Philippine Stock Exchange (PSE), PDEx, SEC, including other exchanges in other jurisdictions and established guidelines on trading of securities. Such sub-accounts shall contain my current securities and various investible holdings in DDS, REIT, bonds, funds, and other securities.
- (12) In the event that I change my designated Beneficiary Account, wherein the branch of account for such newly designated Beneficiary Account is different from the branch of account of my existing Beneficiary Account, I understand and agree that BSC is authorized to close my existing Settlement Account and open a new Settlement Account, which will have the same branch of account as the newly designated Beneficiary Account.
- c. In connection with my Beneficiary Account and Settlement Account, I hereby waive my right to confidentiality under bank secrecy laws, including, but not limited to, Republic Act No. 1405 or the Law on Secrecy of Bank Deposits; Republic Act No. 6426 or the Foreign Currency Deposit Act and Republic Act No. 8791 or the General Banking Law of 2000, as each may be amended; and, Foreign Account Tax Compliance Act (FATCA).
- 6. Settlements. It is agreed that all Securities purchased will be settled not later than the corresponding cut-off time per asset class or product on the applicable settlement date. It is further agreed that interest charges at the prevailing interest rate and penalties irrespective of their origin, including those that may be incurred by you shall be imposed for each day of my delayed payment and such securities purchased shall be registered in your name until such time that it is fully paid. In the event of my failure to pay, any upward or downward fluctuation in the market price shall be for my account and at my risk, until actually sold or disposed of. I understand that the securities market is a rapidly changing market and there are inherent risks of incurring losses in securities transactions. Therefore, I hold you free and harmless against any and all costs, losses, damages, fines, penalties, and taxes which may arise out of the exercise of your powers and functions duly authorized. Furthermore, you are authorized at your own discretion to sell all or a portion of my securities and funds which I guarantee to be free from any and all liens and encumbrances to cover unpaid orders or balances, without prejudice to your right to collect the remaining liability after the sell-out. All electronically executed orders for the purchase of securities will be on cash basis. Unless otherwise agreed. My Settlement Account must contain sufficient funds to cover the purchase price of the Securities, your commission, and all the applicable costs attributable to me as the buyer. Any order inadvertently accepted and executed without sufficient funds in the account will be subject to cancellation or liquidation at your discretion. I am responsible for all of my executed orders, including any orders which exceed available funds in my account. If full funds are not available in the Settlement Account and an order is processed, my payment via the Beneficiary Account, pledge, wire, personal check, cashier's check or money order made payable to you must be promptly submitted to you to assure that such payment will be received and processed on or prior to the corresponding cut-off time per asset class or product on the applicable settlement date. If payment is not received on the applicable settlement date, or as market conditions warrant, my account may be liquidated, without prior notification. In the event that my account is liquidated, I will be liable for any resulting losses and all associated costs incurred by you. In case of remittance of proceeds to an account outside of the Philippines, I acknowledge and agree that the remittance advice by you that the funds are with my custodian bank will be full compliance with the provisions on settlement periods in this Agreement. You will receive dividends on my behalf, and will credit my Settlement Account or issue a check within thirty (30) days after the payable date. I will be notified of any subscription rights received by you in connection with my BDO Securities trading /investment account. I agree that all of your payments will be made to the exact registered account name.
- 7. Online Trading / Investment Facility. The Terms and Conditions for the Online Trading / Investment Facility are incorporated by reference herein and are made an integral part of the general Terms and Conditions as if fully set forth herein:
  - a. I acknowledge that the Online Trading / Investment Facility and the Website, including the software and other contents thereof, are proprietary to you. I warrant and undertake that I shall not nor attempt to tamper with, modify, decompile, reverse engineer or otherwise alter in any way, or attempt to gain unauthorized access to any part of the Online Trading / Investment Facility or Website or any of the contents thereof. I also undertake to immediately notify you if I become aware of any actions described above being perpetrated by another person or entity.
  - b. I agree that, as a condition of using the Online Trading / Investment Facility, I shall notify you within twenty-four (24) hours if:
    - (1) I placed an instruction through the Online Trading / Investment Facility and I did not receive an accurate acknowledgement, in any acceptable form, of my instruction or its execution;
    - (2) I received acknowledgement, in any acceptable form, of a transaction which I did not instruct or any similar occurrence; or
    - (3) I become aware of any unauthorized use of my access code.

I acknowledge and agree that if I fail to immediately notify you when any of the above situations occur, you will not have any liability to me, or to any other person whose claim arises from me.

I further understand that while I may be able to access financial or investment information or services through the Online Trading / Investment Facility, the availability of such information does not constitute a recommendation to buy or sell any of the securities discussed therein, or utilize any investment strategy. Any investment decisions or trade executions I will make through the online trading / investment facility will be based solely on my own evaluation of my financial circumstances and investment objectives. In acting pursuant to my instructions, I understand and agree that you have no liability whatsoever for the results of my own investment strategies, decisions and trade executions, and I shall indemnify and hold you and any of your officers, directors, employees and agents from any and all claim, suit, costs, losses, fines, penalties and taxes which you may incur arising from my own investment strategy and decision to invest and trade in securities with higher risks which may be deemed as product mismatch against my risk profile. Any order entered using my password and trading PIN is mine. If third parties gain access to your services, including my accounts, I will cooperate in defending and indemnifying you against any liability, costs or damages arising out of claims or suits based upon or relating to such access and use.
  - d. I am responsible for knowing the rights and terms of all Securities in my BDO Securities trading / investment account and for monitoring the occurrence of any reorganizations or other events (e.g. stock splits and reverse stock splits) involving my securities.
