With effect from 1 January 2015, BDO Unibank, Inc. Hong Kong Branch (“Branch”) is a Category 2 institution (being an institution not designated as a Category 1 institution) and is required to comply with all the requirement of the Banking (Liquidity) Rules (“Rules”) that are applicable to it insofar as those requirements relating to the Liquidity Maintenance Ratio (“LMR”). Being a Category 2 institution, Liquidity Coverage Ratio, Net Stable Funding Ratio and Core Funding Ratio are not applicable to the Branch.

於 2015 年 1 月 1 日生效起，金融銀行有限公司香港分行（“本行”）作為第 2 類機構（非指定認可為第 1 類機構的機構）會遵守銀行業（流動性）規則（“規則”）符合所有有關流動性維持比率（“LMR”）要求。流動性覆蓋比率、穩定資金淨額比率及核心資金比率不適用於作為第 2 類機構的本行。

As an authorised institution incorporated outside Hong Kong, LMR is calculated on the Branch basis pursuant to rule 10(1)(a) of the Rules.
