

Terms and Conditions:

1. Bench Stylish Mondays (“Benefit”) is exclusive to Bench Mastercard (“Card”) Principal and Supplementary Cardholders (“Cardholders”) who will use their Card to shop at Bench, Partner Global Brands, Suyen Food Brands, and Bench Online Stores every Monday until **June 26, 2023**.
2. Cardholders are entitled to a **20% discount** (“Offer”) every Monday at participating brands, in-store and online, for a minimum single-receipt purchase:

3. Offer applies on purchase of regular-priced items and does NOT apply to:
 - Items on consignment and gift packs;
 - Tier 2 and 3: Cosmetics, Fast Moving Consumer Goods (FMCG), Books, CDs, DVDs, and Magazines;
 - Tier 3 and 4: Shoe Care products from Aldo, Call it Spring and Pedro;
 - Tier 4: Bench Skin Expert products;
 - Tier 5: Purchase of high end brands in Dimensione such as Cappellini, MDF Italia, Arper, Fritz Hansen, Driade, Ozzio, Foscarini and Clei, and items that are consigned and considered low-priced local items (“X-items”);
 - All items from brands: Bench Fix, Bench Beauty, Bench To Go, Bench & Bath and PCX
4. Regular and items not qualified for the Offer may be combined to meet the minimum spend requirement but Offer will only be awarded where applicable as specified in T&C clause #3;
5. Offer is non-transferable, cannot be exchanged for cash or other products and cannot be used in conjunction with other discounts, promotions, discounted items and VIP Card;
6. Splitting of transaction is not allowed. Only one (1) transaction shall be allowed per store, per day;
