INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims primarily for capital growth over the medium to long-term by investing in a selection of exchange-listed equities. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEI).

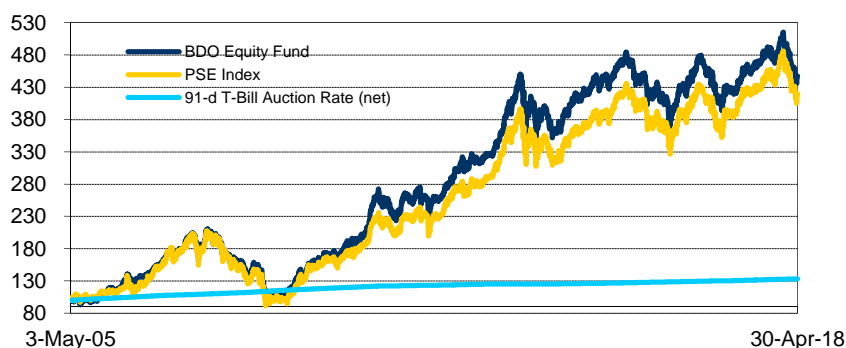

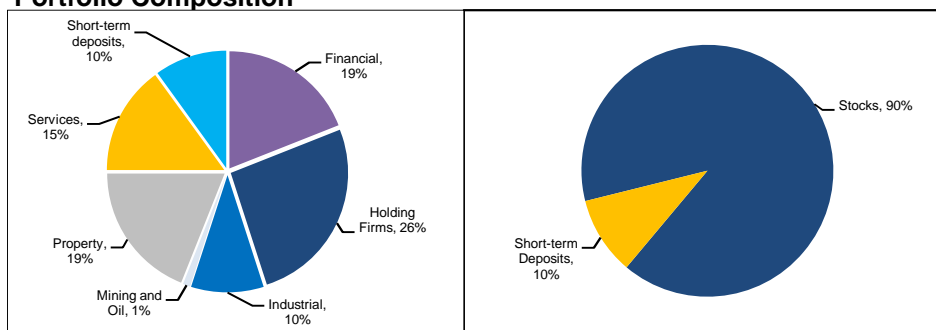
Fund's NAVPU vs Benchmark & Risk-Free Rate

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

Market sentiment remained weak in April with the PSEi closing the month at 7,819, down by 2% MoM. Foreigners continued to dump shares in the market with net outflows for the month reaching \$170M or a total YTD net outflow of almost \$800M. The lack of local buying further pushed the Index lower and at one point hit a one-year low of 7,557. Rising inflation, the deteriorating peso, unremarkable earnings, and the BSP's no-rate-hike stance continued to disappoint investors. Consumer and bank stocks led the decline following soft first quarter corporate results. PGOLD (-9.6% MoM) was sold off after guiding lower revenue growth while URC (-7.6% MoM) posted lower profits on weak sales for domestic goods. Banks also suffered the same fate, BDO (-5.2% MoM); BPI (-7.7% MoM) and SECB (-12.9% MoM) saw a total net outflow of \$47M. It was only towards month-end that the market saw a relief rally. International credit rating agency S&P upgraded the country's credit rating outlook to 'positive' from 'stable' due to sustained fiscal reform amidst economic growth. Nonetheless, expect the market to remain volatile on prevailing concerns on currency and inflation. Look to gradually accumulate on huge market dips.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
