INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims primarily for capital growth over the medium to long-term by investing in a selection of exchange-listed equities. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEI).

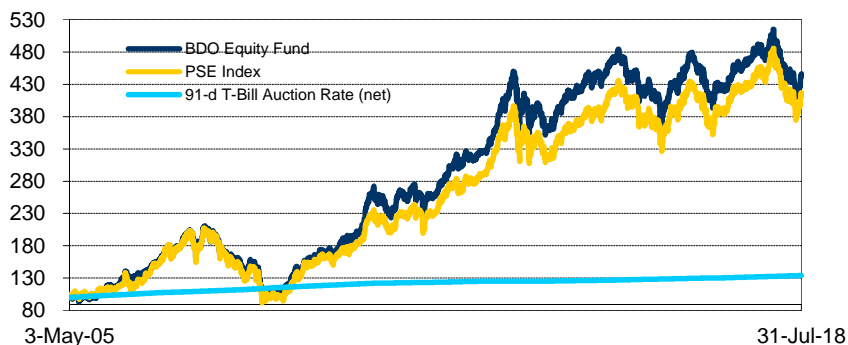

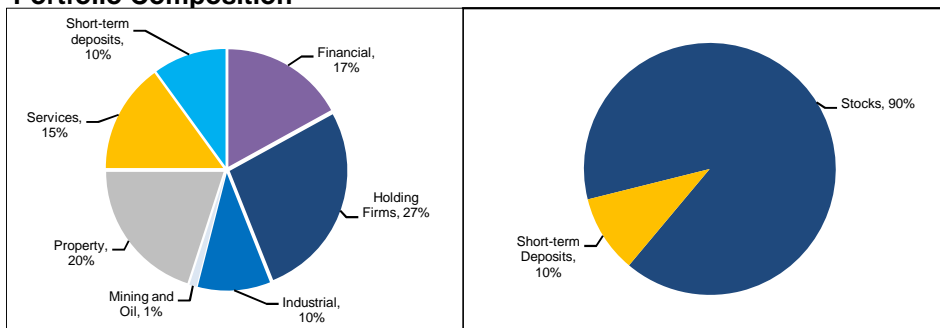
Fund's NAVPU vs Benchmark & Risk-Free Rate

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The PSEi finally ended the month on a strong note after five 5 consecutive months of decline. The index surged 478 points or 6.6% month-on-month to close at 7,672. Both local buying and foreign inflows helped pushed the index to the 7,700 level, a solid 11% recovery from the recent low of 6,923 in mid-July. The month also saw the peso strengthening to P53.10 versus the June level of P53.37. Market sentiment turned positive after the BSP signaled strong policy action in the next Monetary Board meeting on August 9 with inflation hitting 5.2% in June and the peso falling to its 12-year low. Trading volume, however, remained low and July still posted a net foreign outflow of \$49M. It seems that investors have priced in all the negative news and are slowly deploying funds back to the market while foreign funds took quick profits in developed markets and did some bargain hunting in Asian emerging markets. Given this view, expect the market to keep testing the 7,900 resistance though it seems unlikely that a run-up towards the 8,000 yearend target will be in the cards this early.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
