## INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for long-term capital appreciation by substantially investing in listed companies which the Trustee believes to exhibit good environmental, social and governance (ESG) practices. The Fund's benchmark is the Philippine Stock Exchange Composite Index (PSEi).

## CLIENT SUITABILITY

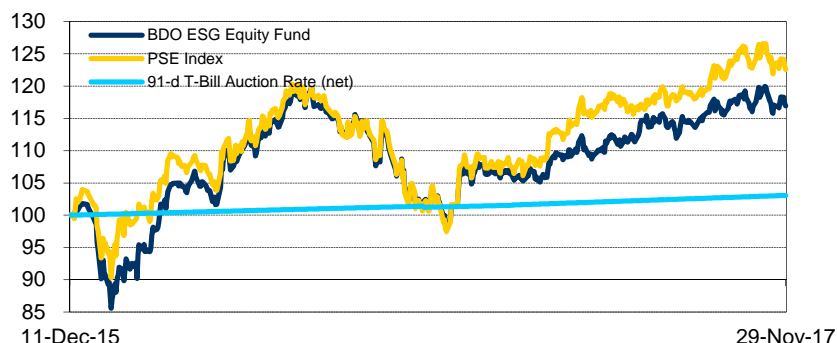

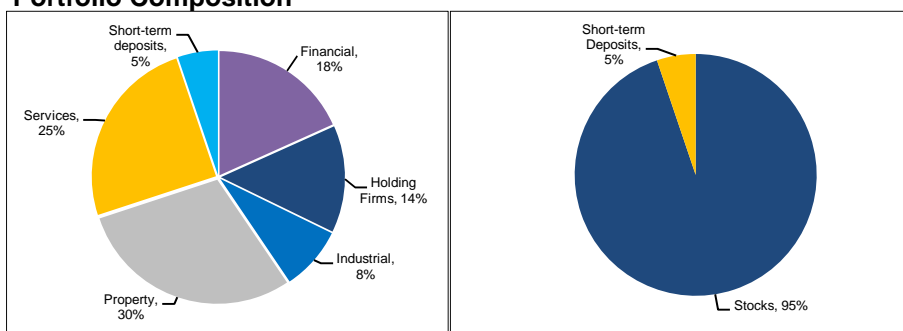
**Fund's NAVPU vs Benchmark & Risk-Free Rate**

## OTHER DISCLOSURES

### OUTLOOK AND STRATEGY

The stock market was off on a strong note in November, hitting another new record intra-day high of 8,605. However, this subsequently prompted investors, particularly on the foreign side, to book gains. Foreigners were net sellers for the first time in eight (8) months despite the better-than-expected third quarter GDP print of 6.9% versus the consensus estimate of 6.6%. Even the Senate's approval of their version of the tax reform program failed to perk up the market. Much of the market weakness stemmed from lackluster 3rd quarter earnings results as well as the sell-off in telco stocks on continued talks regarding the entry of a third player. While there are episodes of profit taking/re-balancing that are currently going on, we maintain our positive long-term outlook in the stock market. The passage and implementation of the tax reform bill should pave the way for the equity market to move to higher ground and we see this largely benefiting sectors like property, banks, retail and infrastructure/construction.

### INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
