

## GOLF INSURANCE

Summary of Insurance Benefits:

**Section I: Golf Clothing, Clubs and Equipment**

Protection for loss or damage to golf clothing, club or golf equipment while in any recognized golf club or driving range due to Fire, Lightning, Burglary, Housebreaking, Larceny, Theft.

**Section II: Other Clothing**

This benefit will reimburse you for loss or damage to your other clothing (other than golf clothing) while in the locker at any recognized golf club or golf driving range anywhere in the world.

**Section III: Third Party**

This benefit will either reimburse or pay in your behalf the amount you are legally liable to pay, up to the limit set under your Schedule of Benefits for claims by a third party in respect of bodily injury or property damage caused while you are practicing or playing golf in any recognized golf courses or golf driving range anywhere in the world.

**Section IV: Accident Insurance**

This benefit will reimburse medical expenses you incur because of an accident injury that you sustain while playing or practicing golf in any recognized golf club or golf driving range anywhere in the world. If in the event such injury results to death, your Golf Insurance will pay the designated beneficiary the sum indicated for Accidental Death and Dismemberment or Disablement under your Schedule of Benefits.

**Section V: Caddies' Medical Expenses**

This benefit will either pay on your behalf or reimburse you for medical and other incidental expenses reasonably incurred in the event that you accidentally injure a caddie or a tee-girl, while you are playing or practicing golf in any recognized golf club or golf driving range, anywhere in the world.

**Section VI: Gold Achievement Benefits**

This benefit will reward you should you make a Hole-In-One or hole out a Double Eagle.
