**INVESTMENT OBJECTIVE AND STRATEGY**

The Fund aims to preserve capital and generate income for tax exempt entities from medium to long-term fixed-income securities with a portfolio weighted average life of not more than five (5) years. The Fund's benchmark is the Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Merit Fund (Medium Term Portfolio) is primarily suitable for participants with moderate risk appetite and who are looking for higher yields and are willing to take the attendant risks that come with portfolios that may have investments with longer tenors. Only tax-exempt Retirement Plans which are deemed reasonable private benefit plans by the Bureau of Internal Revenue (BIR) may participate.
- ♦Participants/trustors are recommended to stay invested in the Fund for at least three (3) years. The Fund is not suitable for short-term investing.

**KEY RISKS AND RISK MANAGEMENT**

**Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

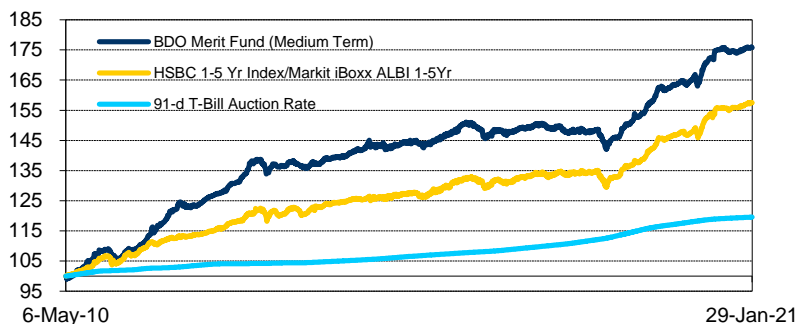

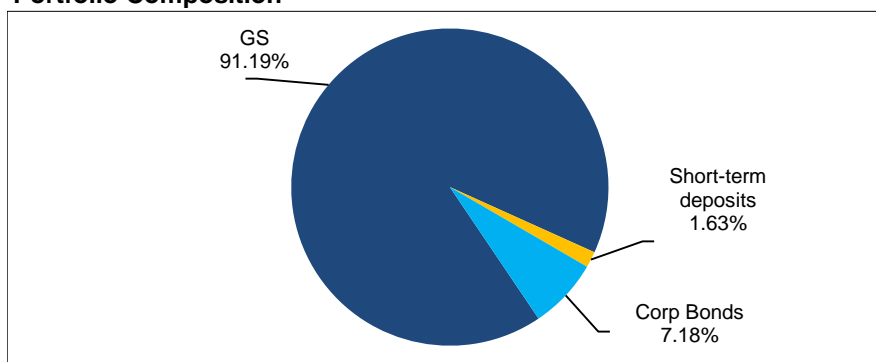

**OTHER DISCLOSURES****OUTLOOK AND STRATEGY**

The Consumer Price Inflation (CPI) print for December continued to surge up to a 22-month high of 3.5%. This figure brings the average inflation for the whole year to 2.6% which is slightly higher than last year's 2.5% but still within the Bangko Sentral ng Pilipinas' (BSP) target range of 2%-4%. Despite the continuous rise of the CPI figure, interest rates remain untouched for the month of January, with commercial banks still offering below the 1% level for one to three month tenors. In addition, Philippines' Gross Domestic Product (GDP) fell by 9.5% for the year 2020 as local economic activities were significantly limited due to restrictions imposed to the community due to the COVID-19 pandemic. The BSP is set to review the monetary policy on February 11. Furthermore, the BVAL yield of the 5-year local government bond ended the month slightly higher at the 2.58%. Merit B's duration remains within its mandate at 3.39 as of the end of January.

**INVESTMENT POLICY / PROSPECTIVE INVESTMENTS**

The Fund may invest in deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity and exchange-listed fixed income securities. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
