## INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for capital preservation and income generation over the medium term by investing in higher yielding medium to long term bond investments and other similar fixed income securities. The Fund's benchmark is the 3-5 Years ROP Weighted Price Index (based on FMPH prices).

## CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Medium Term Dollar Bond Fund is primarily suitable for individual and corporate investors with moderate risk appetite and who are looking for higher yields and are willing to take the attendant risks due to the relatively longer-term nature of the Fund's investments.
- ♦ Participants/trustors are recommended to stay invested in the Fund for at least three (3) years.

## KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

**Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

**Market/Price Risk.** This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

**Liquidity Risk.** This is the possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

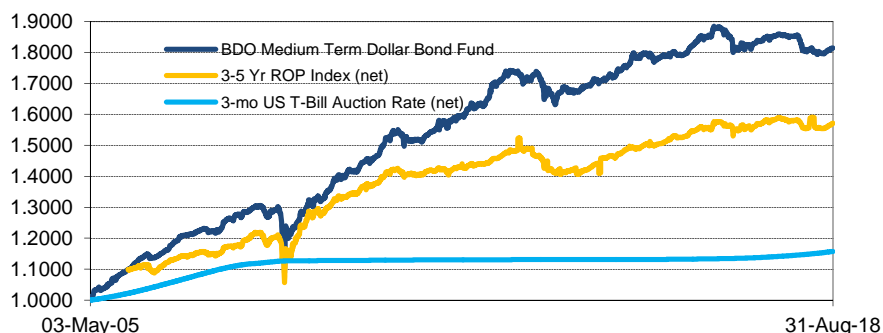

**Fund's NAVPu vs Benchmark & Risk-Free Rate**



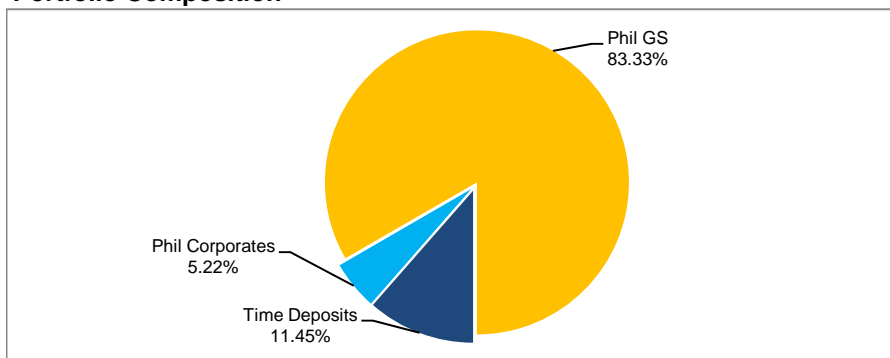

## OUTLOOK AND STRATEGY

The 10yr US Treasury bond yield went down to 2.88% from 2.96% the previous month due to safe haven demand arising from the economic crisis gripping Turkey as well as the greater global trade war issue. US President Trump has repeatedly reiterated his threat to raise tariffs from 10% to 25% on \$200 billion worth of Chinese products. The August FOMC statement contained one major hawkish change, upgrading the pace of economic activity to “strong” from “solid” while the trend in job growth remained strong as the unemployment rate ticked back down to 3.9%. Consequently, more Fed rate hikes are likely to come during the September and December FOMC meetings. However, US Fed Chair Powell did mention in his speech during the Jackson Hole forum that if the economic data deteriorate – ostensibly due to the trade war – the Fed could pause first in 2019. The fund's duration is at 3.25 from last month's 3.30.

## INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in the Trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
