5. Should the Buyer withdraw or cancel the Offer for any reason despite BDO's approval, the Reservation Fee shall be forfeited in favor of BDO, without need of further notice to Buyer of such forfeiture.
6. Buyer shall be solely responsible for the transfer of ownership, registration of the Deed of Absolute Sale, cancellation of existing Chattel Mortgage of the Vehicle, renewal of the registration and shall solely shoulder all taxes and expenses relative thereto.
