INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a portfolio of equity securities and short to long term fixed-income securities. The allocation for equity securities shall be between 40% to 60% of the portfolio or any allocation range that may be prescribed by the Trust Officers Association of the Philippines (TOAP) in consultation with the regulatory authority/ies. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

♦The BDO Peso Balanced Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.

♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

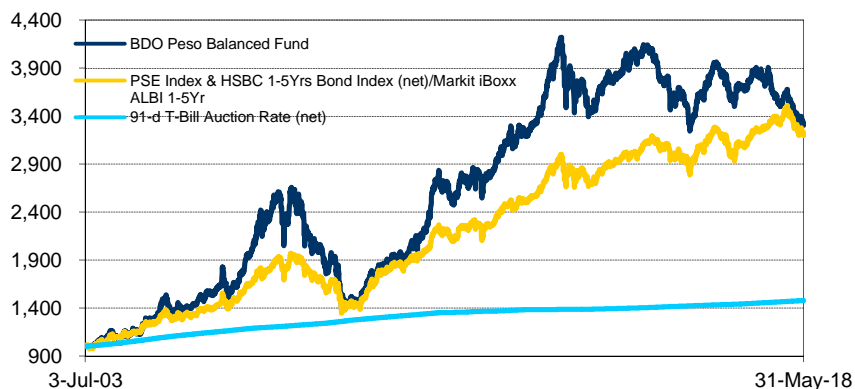

Fund's NAVPU vs Benchmark & Risk-Free Rate



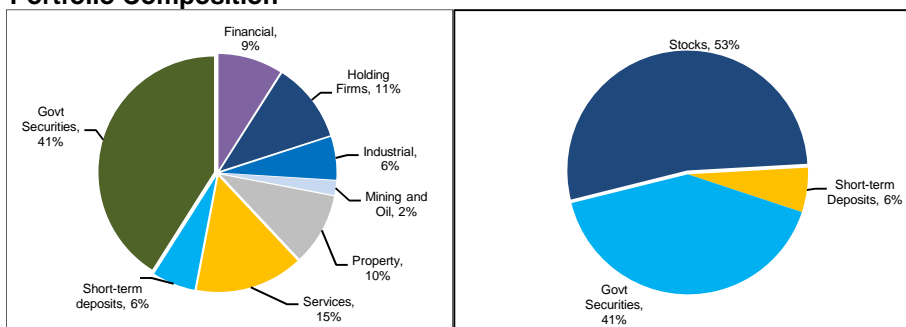

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The stock market continued to languish in May on sustained foreign selling. The PSEi shed more than 300 points to close at 7,497. The index has seen 4 consecutive months of net foreign selling, depressing share prices of Index names such as AEV (-17.2% MoM); TEL (-11.5% MoM) and JGS (-10.7% MoM). Peso weakness and inflation worries continued to hound the market with the peso further depreciating by another 1.5% and inflation creeping to a 5-year high of 4.5%. The BSP finally raised its policy rate by 25 bps to 3.25% as a result. This was followed though by a cut in the reserve requirement by another 1% to 18%, releasing P90 billion of fresh money into the financial system and muddling up its monetary policy stance once again as the contradictory action sent mixed signals to the market. Investors, particularly the locals, remained on the sidelines once more. The market only saw an uptick in activity by month-end due to MSCI rebalancing. Expect the market to trade range-bound between 7,400 and 7,800 levels with downside of 7,200 on lack of market-moving news in the short term. On the other hand, bond yields remained on an uptrend on account of fiscal and Fed rate hike issues. Expect yields to remain elevated on expectation of higher inflation as well.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
