INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a portfolio of equity securities and short to long term fixed-income securities. The allocation for equity securities shall be between 40% to 60% of the portfolio or any allocation range that may be prescribed by the Trust Officers Association of the Philippines (TOAP) in consultation with the regulatory authority/ies. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

♦The BDO Peso Balanced Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.

♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Liquidity Risk. This is the possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss.

For the Fixed Income portfolio, the Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

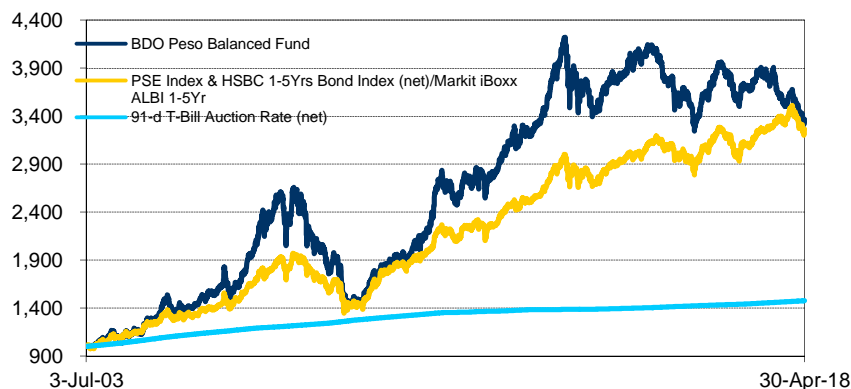

Fund's NAVPU vs Benchmark & Risk-Free Rate



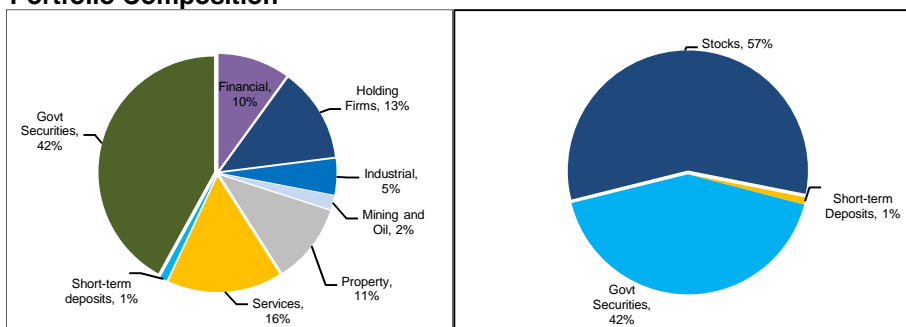

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

Market sentiment remained weak in April with the PSEi closing the month at 7,819, down by 2% MoM. Foreigners continued to dump shares in the market with net outflows for the month reaching \$170M or a total YTD net outflow of almost \$800M. The lack of local buying further pushed the Index lower and at one point hit a one-year low of 7,557. Rising inflation, the deteriorating peso, unremarkable earnings, and the BSP's no-rate-hike stance continued to disappoint investors. Consumer and bank stocks led the decline following soft first quarter corporate results. PGOLD (-9.6% MoM) was sold off after guiding lower revenue growth while URC (-7.6% MoM) posted lower profits on weak sales for domestic goods. Banks also suffered the same fate, BDO (-5.2% MoM); BPI (-7.7% MoM) and SECB (-12.9% MoM) saw a total net outflow of \$47M. It was only towards month-end that the market saw a relief rally. International credit rating agency S&P upgraded the country's credit rating outlook to 'positive' from 'stable' due to sustained fiscal reform amidst economic growth. Nonetheless, expect the market to remain volatile on prevailing concerns on currency and inflation. Look to gradually accumulate on huge market dips. On the bond market, investors had been pricing in higher yields on mixed signals from BSP. All eyes are on the May 10 Monetary Board meeting on whether the BSP will finally raise rates. Expect bond yields to trend higher on rising inflation coupled with the expectation of higher government borrowings for its infrastructure program.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
