INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a portfolio of equity securities and short to long term fixed-income securities. The allocation for equity securities shall be between 40% to 60% of the portfolio or any allocation range that may be prescribed by the Trust Officers Association of the Philippines (TOAP) in consultation with the regulatory authority/ies. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

♦The BDO Peso Balanced Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.

♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

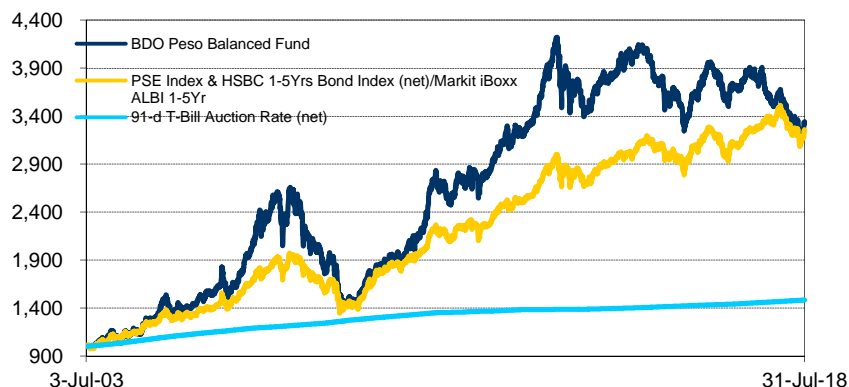

Fund's NAVPU vs Benchmark & Risk-Free Rate



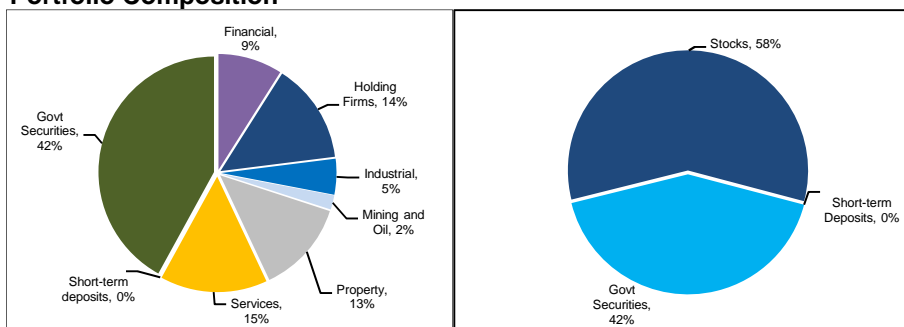

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The PSEi finally ended the month on a strong note after five 5 consecutive months of decline. The index surged 478 points or 6.6% month-on-month to close at 7,672. Both local buying and foreign inflows helped pushed the index to the 7,700 level, a solid 11% recovery from the recent low of 6,923 in mid-July. The month also saw the peso strengthening to P53.10 versus the June level of P53.37. Market sentiment turned positive after the BSP signaled strong policy action in the next Monetary Board meeting on August 9 with inflation hitting 5.2% in June and the peso falling to its 12-year low. Trading volume, however, remained low and July still posted a net foreign outflow of \$49M. It seems that investors have priced in all the negative news and are slowly deploying funds back to the market while foreign funds took quick profits in developed markets and did some bargain hunting in Asian emerging markets. Given this view, expect the market to keep testing the 7,900 resistance though it seems unlikely that a run-up towards the 8,000 yearend target will be in the cards this early. On the interest rate front, bond yields have remained on an uptrend and this trend is expected to continue in the coming months on the back of BSP's move to halt further cuts in reserve requirement ratio (RRR), as well as the pronouncement of a more hawkish policy rate stance, and the National Government's ramped-up borrowing plan to finance its aggressive infrastructure program.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
