INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a portfolio of equity securities and short to long term fixed-income securities. The allocation for equity securities shall be between 40% to 60% of the portfolio or any allocation range that may be prescribed by the Trust Officers Association of the Philippines (TOAP) in consultation with the regulatory authority/ies. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

KEY RISKS AND RISK MANAGEMENT

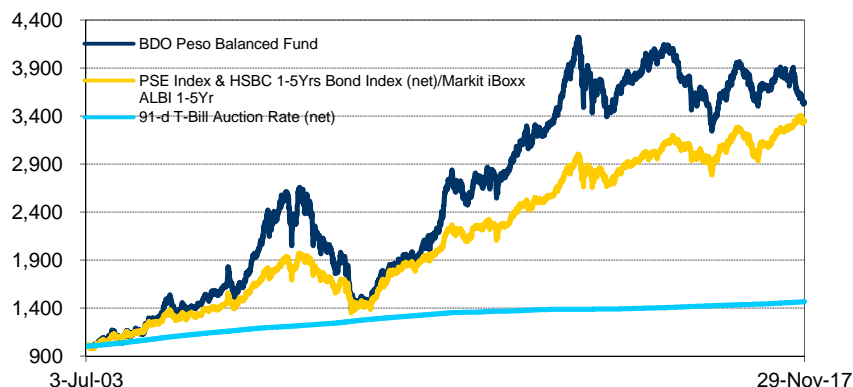

Fund's NAVPU vs Benchmark & Risk-Free Rate



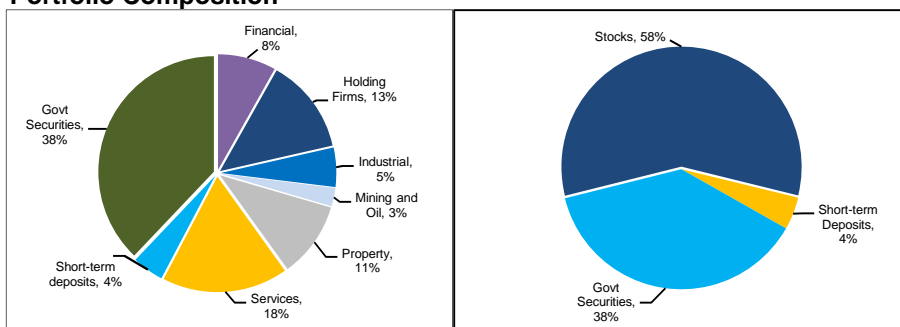

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The stock market was off on a strong note in November, hitting another new record intra-day high of 8,605. However, this subsequently prompted investors, particularly on the foreign side, to book gains. Foreigners were net sellers for the first time in eight (8) months despite the better-than-expected third quarter GDP print of 6.9% versus the consensus estimate of 6.6%. Even the Senate's approval of their version of the tax reform program failed to perk up the market. Much of the market weakness stemmed from lackluster 3rd quarter earnings results as well as the sell-off in telco stocks on continued talks regarding the entry of a third player. While there are episodes of profit taking/re-balancing that are currently going on, we maintain our positive long-term outlook in the stock market. The passage and implementation of the tax reform bill should pave the way for the equity market to move to higher ground and we see this largely benefiting sectors like property, banks, retail and infrastructure/construction. On the other hand, the peso bond market traded flat even as yields are expected to trend higher in the coming months on the back of the possible increase in borrowings next year and expectations over the sustained tightening of US monetary policy.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
