INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims to achieve capital appreciation by investing in a portfolio of equity securities and short to long term fixed-income securities. The allocation for equity securities shall be between 40% to 60% of the portfolio or any allocation range that may be prescribed by the Trust Officers Association of the Philippines (TOAP) in consultation with the regulatory authority/ies. The Fund's benchmark is 50% Philippine Stock Exchange Composite Index (PSEi) and 50% Markit iBoxx ALBI Philippines 1-5 (Domestic) Index (IBXXPH15).

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Peso Balanced Fund is primarily suitable for individual and corporate investors with balanced risk appetite and who are aware of the opportunity for high yields that portfolios with stock market investments may provide but are also knowledgeable of the possibility of capital losses that such investments may entail.
- ♦Participants/trustors are recommended to stay invested in the Fund for more than three (3) years.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Liquidity Risk. This is the possibility for an investor to experience losses due to the inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss.

For the Fixed Income portfolio, the Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

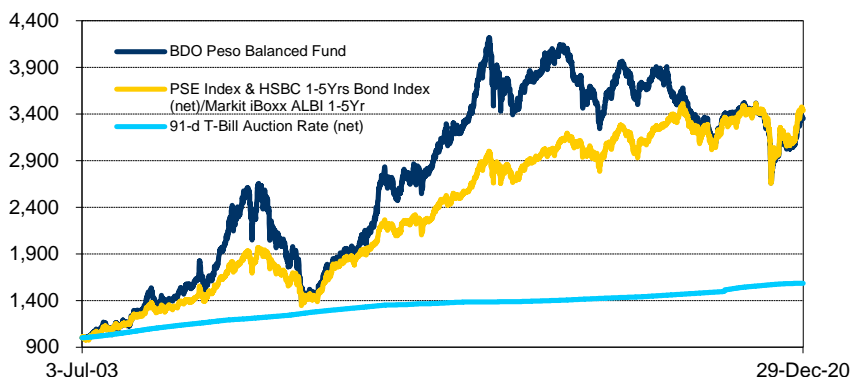

Fund's NAVPU vs Benchmark & Risk-Free Rate



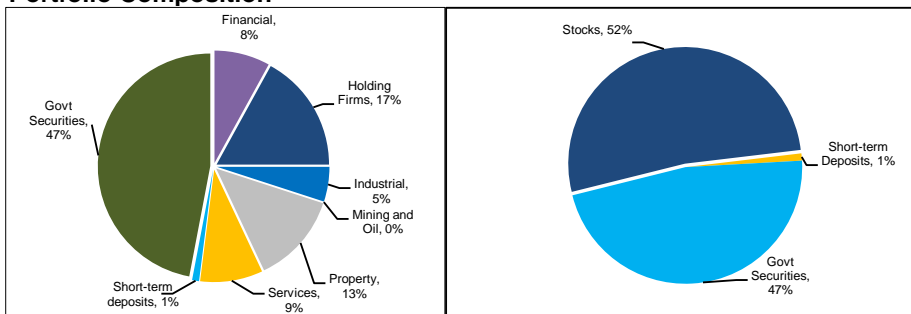

OTHER DISCLOSURES**OUTLOOK AND STRATEGY**

The PSEI continued to rally in December over the optimism on the vaccine roll-out. The equities market gained 5.1% for the month. The PSEI ended the year at 7,139, a decent improvement from the March low of 4,623 triggered by the Covid pandemic. The hard lockdown dragged the economy into a recession however easing quarantine measures mid-year gradually lifted market sentiment. Reopening the economy became the market theme as investors rotate to cyclical sectors like bank and property. Property names mostly gained in December led by Robinsons Land (+27.56% m/m) and Ayala Land (+7.63% m/m) while essential retailers Puregold (-2.73% m/m) and Robinsons Retail Holdings (-4.41% m/m) were sold down the most. The reopening theme is seen to further drive the market on the back of vaccine hopes. A proper and an earlier than expected vaccine roll-out is seen as a positive catalyst for the market.

On the local bond market, yields slipped lower as investors continue to focus on BSP's move to remain in an accommodative stance for a long time. Inflation rate in November rose 3.3% and further accelerated higher in December at 3.5% driven by higher food inflation. Expect yields to remain at low levels as BSP maintains a dovish monetary policy stance.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in exchange-listed equities and fixed income securities, deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP and tradable securities issued by any supranational entity. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
