- The Remitter signs this Remittance Acceptance Form and attests that all of the information contained herein are true and accurate. When signing this form, the Remitter confirms that he/she is fully informed of the terms and conditions of the remittance agreement and that these also apply to all his/her subsequent remittances.
- It is the Remitter's responsibility to inform BDO Remit (USA), Inc. of any change or update to the information provided in this Remittance Acceptance Form, as well as, to provide any supporting document proving such changes or updates.
- Funds shall be transferred in favor of the Beneficiary, through BDO Unibank, Inc. in the Philippines.
- Funds shall be paid to the Beneficiary in Philippine Pesos, unless otherwise specified by the Remitter, in accordance with the exchange control regulations of the United States of America and the Philippines.

### IV. Data Privacy and Processing of Personal Data

  - c) Certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
