We reply to your request for clarification on the news article titled "BDO forecasts sustained growth no matter the global volatilities" published in today's issue of the BusinessMirror, the pertinent portion of which reads:

"BDO Unibank Inc., the country's largest bank, is open to consolidating with other banks to take advantage of scale and other business opportunities.

BDO Chairman Teresita Sy Coson said the bank is always open to scale up its business and not closing its mind for another chance at higher growth or earnings.

'We're open to any kind of consolidation depending on where the opportunity is. Yes, there are some well-known big banks that are coming in and there also are opportunities for consolidating here among ourselves. We're open to any model. Acquisition and consolidation have always been key components to BDO's growth expansion. BDO is open to different models and formats depending on the circumstances and the advantages to BDO.


