#### INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for capital preservation and income generation by investing in a diversified portfolio of fixed income instruments with average duration of less than one (1) year. The Fund's benchmark is the 91-day T-Bill rates.

#### CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Short Term Fund is primarily suitable for individual and corporate investors with moderate risk appetite and who are looking for investments with yields relatively higher than those of savings and time deposit accounts.
- ♦Participants/trustors are recommended to stay invested in the Fund for at least one (1) year.

#### KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

**Interest Rate Risk.** This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

**Market/Price Risk.** This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

**Credit Risk/Default Risk.** This is the possibility for an investor to experience losses due to a borrower's failure to pay the principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security, which the borrower issued.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

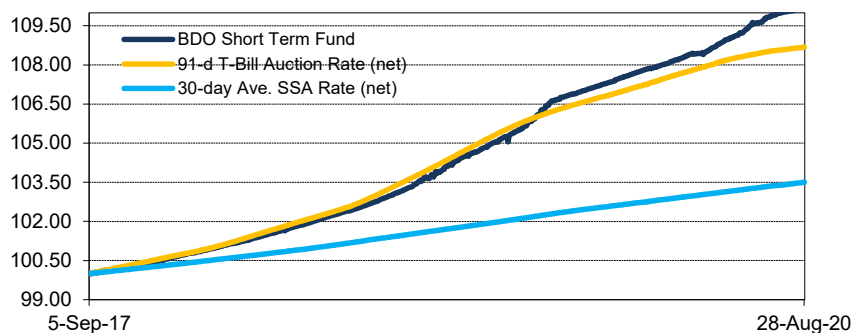

**Fund's NAVPu vs Benchmark & Bloomberg Average 30-day SSA Rate**



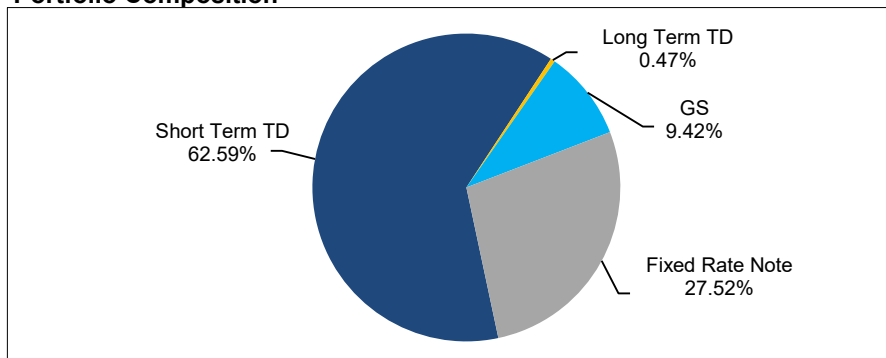

## OUTLOOK AND STRATEGY

The local economy continued to be hampered by the sustained uptrend in the number of covid-19 cases, particularly in Metro Manila where quarantine measures were tightened once more during the first two weeks of August. Investors flocked to safer assets in response and this move continued to apply downward pressure on yields of short-term instruments. The award for the August 24 T-bill auction was lower compared to the previous month, as the 91-, 182-, and 364-day tenors fetched rates of 1.131%, 1.407%, and 1.751%, respectively. Time deposit rates have also remained low, with most commercial banks still offering less than 1% for one- to three-month placements. This low interest rate environment has persisted despite the monthly consumer price index (CPI) inflation climbing for a second consecutive month to 2.7% in July. Partly in response, the BSP did not cut its policy rate in its August meeting, keeping it at the all-time low of 2.25% despite the massive slowdown in second-quarter GDP growth. The BSP has already lowered its key rate by 175 basis points this year and further action is not expected for the remainder of 2020, except if further deterioration of economic conditions leave monetary officials with little choice but to resort to further monetary easing. STF remains invested in a mix of time deposits and short-term government and corporate bonds. Its duration at the end of August remains within its mandate at 0.60 years.

## INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity and exchange-listed fixed income securities. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
