INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for capital preservation and income generation by investing in a diversified portfolio of fixed income instruments with average duration of less than one (1) year. The Fund's benchmark is the 91-day T-Bill rates.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Short Term Fund is primarily suitable for individual and corporate investors with moderate risk appetite and who are looking for investments with yields relatively higher than those of savings and time deposit accounts.
- ♦Participants/trustors are recommended to stay invested in the Fund for at least one (1) year.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Credit Risk/Default Risk. This is the possibility for an investor to experience losses due to a borrower's failure to pay the principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security, which the borrower issued.

Reinvestment Risk. This is the risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

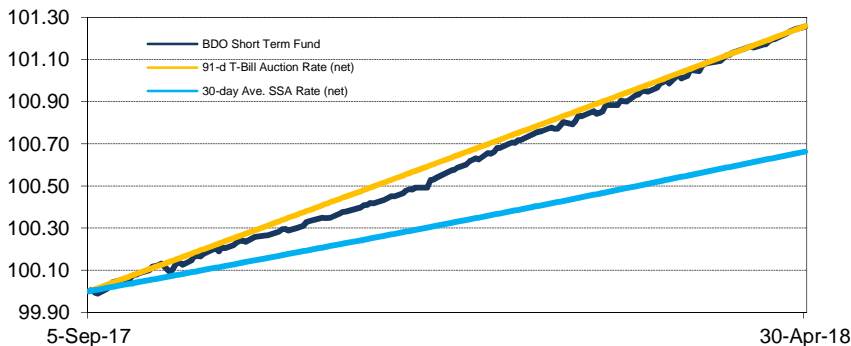

Fund's NAVPu vs Benchmark & Bloomberg Average 30-day SSA Rate



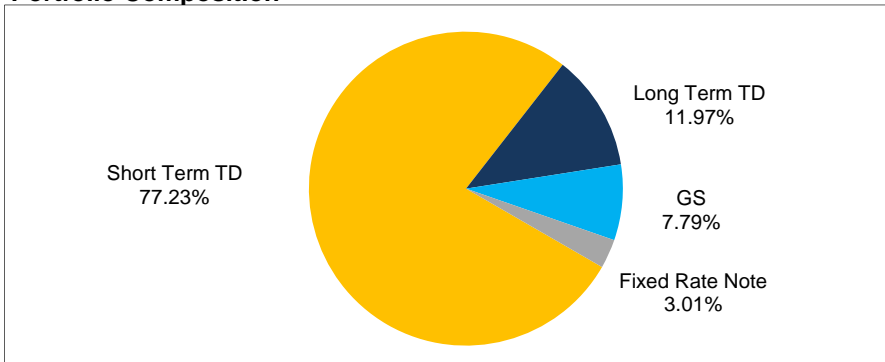

OUTLOOK AND STRATEGY

The March CPI inflation figure came in at 4.3%, exceeding the BSP's target range of 2%-4%. The most notable price increases came from alcoholic beverages and tobacco, food and non-alcoholic beverages, and housing, water, electricity and gas. The BSP has acknowledged the pick-up in local inflation which was triggered by several factors: an artificial shortage of rice, rising fuel prices, and the implementation of additional tariffs on oil and sugary drinks at the beginning of the year. The inflationary environment has pushed the Philippine peso to the P52 level against the US dollar – its weakest since 2006. Despite the uptick in inflation and rising interest rate environment in the United States, it remains uncertain whether the BSP will raise its key rate. However, a high CPI figure for April could lead to the BSP taking action during its third meeting for the year which will be held in the second week of May. Meanwhile, many commercial banks have increased time deposit rates for 1-3 month placements to the 3.0%-3.5% level. STF remains invested in time deposits, short term government securities, and corporate bonds. As of the end of April, the fund's average life and duration were at 0.68 years.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity and exchange-listed fixed income securities. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
