INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for capital preservation and income generation by investing in a diversified portfolio of fixed income instruments with average duration of less than one (1) year. The Fund's benchmark is the 91-day T-Bill rates.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Short Term Fund is primarily suitable for individual and corporate investors with moderate risk appetite and who are looking for investments with yields relatively higher than those of savings and time deposit accounts.
- ♦Participants/trustors are recommended to stay invested in the Fund for at least one (1) year.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Credit Risk/Default Risk. This is the possibility for an investor to experience losses due to a borrower's failure to pay the principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security, which the borrower issued.

Reinvestment Risk. This is the risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

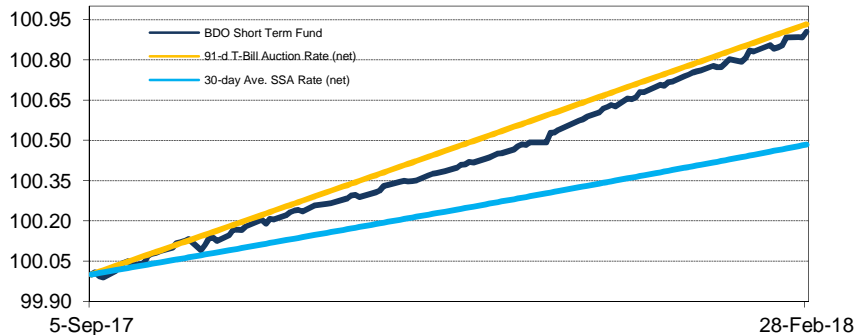

Fund's NAVPu vs Benchmark & Bloomberg Average 30-day SSA Rate



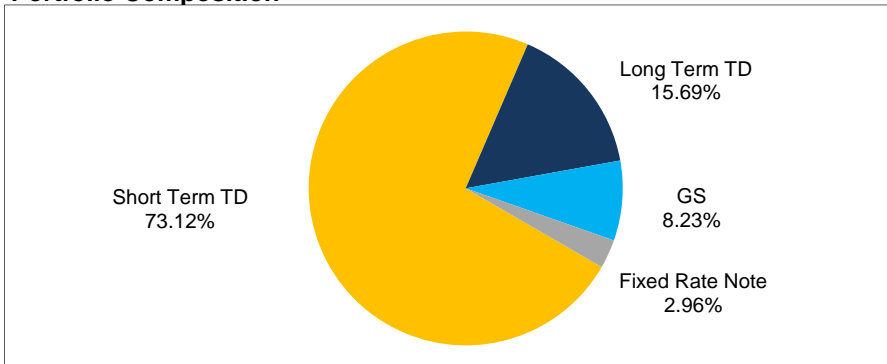

OUTLOOK AND STRATEGY

The implementation of increased taxes on fuel and sugary drinks effective January caused monthly CPI inflation to jump to 4% - the highest level recorded since October 2014. Despite inflation hitting the upper end of its 2%-4% target range, the Bangko Sentral ng Pilipinas (BSP) believes that the upturn due to the new taxes is temporary; thus, it kept its key interest rate unchanged at 3% during its February meeting. However, the market continues to price in two policy rate hikes within the year. On the contrary, in a surprise move also late February, the BSP announced a cut in its reserve requirement ratio from 20% to 19% for implementation in early March. This allowed an estimated P90 billion in liquidity to re-enter the money market. This influx of liquidity in the system could put downward pressure on short-tenor yields. Meanwhile, local commercial banks continued to offer 3.0%-3.5% for 1-3 month placements over the month of February, though rates may normalize back to the 2.0%-2.5% range after the reserve cut takes effect. The Fund remains invested in a mix of short- and long-term time deposits coupled with a slight exposure in a commercial fixed-rate note. The Fund's weighted average life and duration were at 0.84 years as of the end of February.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity and exchange-listed fixed income securities. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
