INVESTMENT OBJECTIVE AND STRATEGY

The Fund aims for capital preservation and income generation by investing in a diversified portfolio of fixed income instruments with average duration of less than one (1) year. The Fund's benchmark is the 91-day T-Bill rates.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- ♦The BDO Short Term Fund is primarily suitable for individual and corporate investors with moderate risk appetite and who are looking for investments with yields relatively higher than those of savings and time deposit accounts.
- ♦Participants/trustors are recommended to stay invested in the Fund for at least one (1) year.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk. This is the possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

Market/Price Risk. This is the possibility for an investor to experience losses due to changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

Credit Risk/Default Risk. This is the possibility for an investor to experience losses due to a borrower's failure to pay the principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security, which the borrower issued.

Reinvestment Risk. This is the risk associated with the possibility of having lower returns or earnings when maturing funds or the interest earnings of funds are reinvested.

The Fund employs a risk management policy based on modified duration. Modified duration measures the sensitivity of bond prices to interest rate movements. As interest rates rise, bond prices fall. The higher the duration, the more the NAVPU will fluctuate in relation to changes in interest rates. All the Fund's investment outlets undergo evaluation in accordance with the Trustee's Investment Policy Manual. Regulatory exposure limits are monitored on a regular basis. The Fund may also use financial derivative instruments solely for the purpose of hedging risk exposures.

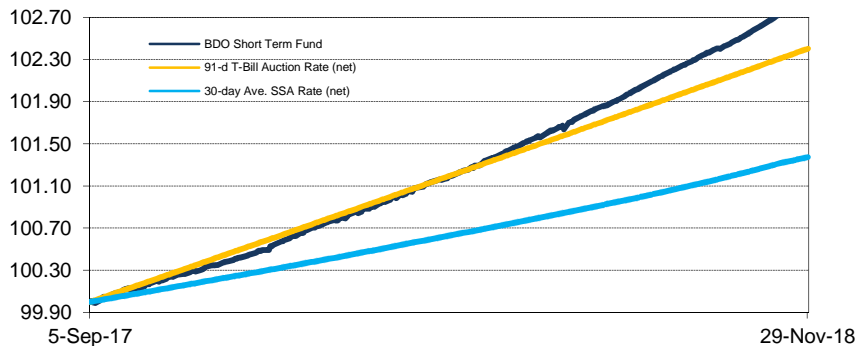

Fund's NAVPu vs Benchmark & Bloomberg Average 30-day SSA Rate



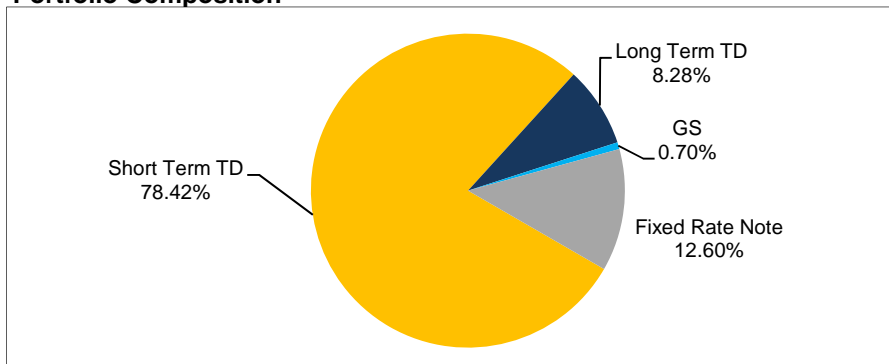

OUTLOOK AND STRATEGY

CPI inflation for the month of October remained steady at 6.7% for the second consecutive month. Food and non-alcoholic beverages, alcoholic beverages and tobacco, and transportation continued to feature the largest price increases. In response, the Bangko Sentral ng Pilipinas (BSP) raised its key interest rate by 25 basis points to 4.75% in its November meeting. The BSP has now increased its key rate by a total of 175 basis points since May. The market's consensus though is that the BSP will no longer institute further rate hikes for the rest of the year, but will have one or two in 2019, depending on the volatility of the exchange rate and its impact on inflation. Also in play for next year is the likely renewed reduction of the BSP's reserve requirement ratio in order to release much-needed liquidity into the market and ease the upward pressure on interest rates coming from crowding out effects. Meanwhile, commercial banks continued to increase their time deposit offerings and by the end of November, one month placements were fetching as much as 6% and one year deposits saw offers for 6.5%. STF remains invested in a mix of time deposits, corporate bonds, and commercial fixed rate notes. As of the end of November, the fund's duration was at 0.61 years.

INVESTMENT POLICY / PROSPECTIVE INVESTMENTS

The Fund may invest in deposits in the trustee's bank or in other banks, securities issued or guaranteed by the Philippine Government or the BSP, tradable securities issued by any supranational entity and exchange-listed fixed income securities. Subject to BSP guidelines and the Trustee's Trust Committee approval, the Fund may also avail of financial derivative instruments solely for the purpose of hedging risk exposures, as well as invest in other tradable investment outlets/categories as may be deemed suitable for the Fund.
